Hazardous Cargo Moves Safely Through Texas

The Waste Isolation Pilot Plant (WIPP) is a deep geologic repository in New Mexico used to store transuranic waste far from major population areas. Transuranic waste is a byproduct of weapons production, nuclear research and power production. This waste consists of protective gear, tools, residue, debris and other items contaminated with small amounts of radioactive elements. Although transuranic waste is a low-level radioactive waste, the U.S. Department of Energy has established a system for safely transporting it to the WIPP site for permanent disposal. The WIPP route through Texas covers more than 650 miles of roadways through 20 counties and 40 municipal jurisdictions. Three to five WIPP transportation trucks cross our state each month and are monitored carefully according to a detailed plan. But what should be done if an incident occurs along the WIPP route? Area

first responders and citizens should follow a three-tiered protection principle: Time, Distance, and Shielding. According to the U.S. Nuclear Regulatory Commission, "Time, distance, and shielding measures minimize your exposure to radiation in much the same way as they would to protect you against overexposure to the sun." First, limiting one's exposure time is the primary method of reducing radiation dosage, spending as little time near a source as possible. Next, one should move away from a radiation source as quickly as possible. Finally, one should find shielding or a barrier such as protective gear or a building or wall between a radiation source and one's position. Proper shielding will either eliminate or greatly reduce contamination and exposure potential. In addition, preparedness activities that can strengthen your community's ability to respond include

- Updating related annexes to your emergency operations plan;
- Participating in training opportunities available through PreparingTexas.org;
- Participating in exercises relevant to nuclear or radiological incidents.

The TDEM Exercise Unit participated in the FEMA Region 6 Annual Training and Exercise Planning Workshop (TEPW) to develop a regional strategy for the next three-year training and exercise cycle. Participating states included Arkansas, Louisiana, New Mexico, Oklahoma, and Texas. A representative from the National Exercise Program previewed some of the new exercise resources that will be available to local and state agencies. We will keep you informed as more information becomes available. Separately we have begun planning for the 2018 Coastal Bend Hurricane Exercise. We are in the early stages of the planning and will provide more information in the coming months.

In the meantime, the Exercise unit will take to the road to deliver the FEMA L-146 Indirect Delivery of the Homeland Security Exercise and Evaluation Program (HSEEP) class. Test your knowledge of emergency management by deciding whether each statement is true or false.
