CONSIDER AUTHORIZING THE COUNTY JUDGE TO ACCEPT GRANT FUNDS FROM THE OFFICE OF THE GOVERNOR-HOMELAND SECURITY GRANT PROGRAM FOR THE REGIONAL SWAT TEAM EQUIPMENT ENHANCEMENT PROJECT.

Upon a motion by Patti Jones, seconded by Gilbert Flores, the court unanimously voted approval authorizing the County Judge to accept grant funds from the Office of the Governor-Homeland Security Grant Program for the Regional SWAT Team Equipment Enhancement Project as presented by Dan Corbin.

Upon a motion by Gilbert Flores, seconded by Patti Jones, the court unanimously voted approving to authorize the County Judge to sign an engagement letter to retain Crenshaw, Dupree, and Milam to provide legal representation to both Lubbock County and Lubbock County employee Pedro Gaona, Jr. relating to a citation issued to Mr. Gaona on October 1, 2018, while Gaona was in the course and scope of his employment and duties with Lubbock County Road & Bridge Department as presented by Neal Burt.
